Purpose of Amendment: The purpose of this amendment is to update RFA-ACE-001 to extend the application deadline and extend the deadline for questions related to this opportunity. Specific revisions are detailed herein.

1. Extend the Closing Date for Applications for RFA-ACE-001.
 - On the title page of the Request for Applications (RFA), remove the following statement:
“Closing Date for Applications: November 2, 2022, 12:00 Eastern Daylight Time (GMT-4)”

And replace with:
*Closing Date for Applications: **November 11, 2022, 12:00 Eastern Standard Time (GMT-5)***
 - On the title page of the RFA, remove the following statement:
“If an applicant has trouble uploading an application to the website, please immediately contact grants_nof@ftf-msp.org before the November 2, 2022 deadline.”

And replace with:
*If an applicant has trouble uploading an application to the website, please immediately contact grants_nof@ftf-msp.org before the **November 11, 2022** deadline.*
 - On page 1 of the Technical Application Template (Attachment 1), remove the following statement:
“All applications are due no later than 12:00 Eastern Daylight Time (GMT-4) on November 2, 2022”

And replace with:
*All applications are due no later than **12:00 Eastern Standard Time (GMT-5) on November 11, 2022***

2. Extend the deadline for questions regarding RFA-ACE-001.

- On the title page of the RFA, remove the following statement:
“Deadline for Questions: October 25, 2022, 12:00 Eastern Daylight Time (GMT-4)”

And replace with:

*Deadline for Questions: **November 2, 2022, 12:00 Eastern Standard Time (GMT-5)***

- On page 3, under Questions, remove the following statement:
“Please submit any questions regarding the RFA process or activity to grants_nof@ftfmisp.org. Questions will be answered weekly, and responses will be posted to the MSP Grants website. The last posting will be no later than October 25, 2022.”

And replace with:

*Please submit any questions regarding the RFA process or activity to grants_nof@ftfmisp.org. Questions will be answered weekly, and responses will be posted to the MSP Grants website. The last posting will be no later than **November 8, 2022**.*

End of Amendment
