Purpose of Amendment: The purpose of this amendment is to replace the “*Type of Anticipated Investment Funding*” clause and change the definition of construction to remove the word “*Painting*”

On page 2 of the RFA, delete the following clause.

Type of Anticipated Investment Funding: MSP will issue performance-based grants ranging between \$250,000 - \$500,000 United States Dollar (USD) to establish partnerships with firms and/or investors for meeting the development objectives stated in Section 1. Under this solicitation, MSP will review applicants in two groups: Group 1 will include all applications received by the initial December 9, 2022, deadline; Group 2 will include all applications received between December 10, 2022, and the second deadline of January 27, 2023. The total amount of funding available for this RFA, including both groups 1 & 2, is approximately \$1,000,000.

Replace it with the below clause.

Type of Anticipated Investment Funding: MSP will issue performance-based grants ranging between \$250,000 - \$500,000 United States Dollar (USD) to establish partnerships with firms and/or investors for meeting the development objectives stated in Section 1. Under this solicitation, MSP will review applicants in two groups: Group 1 will include all applications received by the initial December 9, 2022, deadline; Group 2 will include all applications received between December 10, 2022, and the second deadline of January 27, 2023. The total amount of funding available for this RFA, including both groups 1 & 2, is approximately \$1,000,000 although funding can be adjusted based on availability of funds.

On Attachment 2: Partnership budget bullet 1, delete the below definition of construction
